Directs Department of Education to award grants to improve early literacy in state.

HB 3199

CARRIED OVER FROM THE 03/27/2023 AGENDA: Requires Department of Education to convene advisory group to review physical education requirements for certain students in grades six through eight.

HB 3204

CARRIED OVER FROM THE 03/27/2023 AGENDA: Modifies timelines and requirements for when school district makes determination whether to give approval for student to enroll in virtual public charter school not sponsored by school district.

HB 3236 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 03/27/2023 AGENDA: Authorizes expenditures from Statewide Education Initiatives Account for funding of regional career and technical education programs.

HB 3288

CARRIED OVER FROM THE 03/27/2023 AGENDA: Directs State Board of Education to adopt uniform standards related to collection of specified data.

HB 3014 **

**Subsequent Referral(s) to Ways and Means

Directs State Board of Education to adopt rules that allow for reimbursement of school district expenses incurred in lieu of transporting students.

HB 2767

Establishes requirements for approving recovery schools.

HB 3595

Establishes factors to be considered when Superintendent of Public Instruction enters into contract with education service district or school district to provide educational services to youths in Youth Corrections Education Program or Juvenile Detention Education Program.

HB 2281

Requires school districts and public charter schools to designate civil rights coordinator.

HB 2690

Requires school district to pay classified school employee not less than 10 percent more than minimum wage that applies to all employees who work in this state and not less than 15 percent more than minimum wage if classified school employee provides support to students with individualized education program or who are enrolled in special education.

HB 3030 **

**Subsequent Referral(s) to Ways and Means

Establishes Universal School Meal Account for purpose of reimbursing school districts for certain costs incurred in providing federally reimbursable meals.
