Public Hearing

HB 2484

Directs Department of State Fire Marshal to coordinate urban search and rescue function of this state.

HB 3484 **

**Subsequent Referral(s) to Ways and Means

Establishes State Fire Marshal Firefighting Costs Fund.

HB 3485

Provides State Fire Marshal with certain additional discretionary powers.

HB 2522

Requires governing body of county that contains at-risk land, as defined, to develop, or solicit proposals for development of, fire response plan or wildfire response plan.

HB 2508 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Department Office of Emergency Management to administer grant program in support of projects to consolidate and modernize or upgrade public safety answering points.

HB 2284

Increases fees Public Employees Retirement Board may charge in connection with payment of public employee retirement benefits to alternate payee.

HB 2297

Requires Public Employees Retirement Board to study retirement credit for military service.

HB 3127

Prohibits installation or download of certain covered products onto state information technology assets.

HB 2875

Excludes hours of overtime worked for Oregon State Police from limitations on inclusion of overtime in final average salary for purposes of Oregon Public Service Retirement Plan.

HB 2285

Removes obsolete provisions relating to Social Security Revolving Account.
