HB 2471

CARRIED OVER FROM THE 03/28/2023 AGENDA: Requires Oregon Health and Science University, in consultation with Oregon Department of Administrative Services and Department of Revenue, to conduct study to determine how best to revise repayment method for individuals who receive scholarship from Scholars for a Healthy Oregon Initiative, but who do not fulfill required service agreement.

HB 2472

CARRIED OVER FROM THE 03/28/2023 AGENDA: Requires public universities to develop specified policies and accountability mechanisms for behavior at interscholastic activities, including sporting events.

HB 2740

CARRIED OVER FROM THE 03/28/2023 AGENDA: Establishes uniform method for calculating eligibility of part-time faculty member of community college or public university for certain health care, retirement and other benefits.

HB 2961 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 03/28/2023 AGENDA: Appropriates \$5,000,000 to Higher Education Coordinating Commission for allocation to expand scope and community reach of college access and success programs at public universities and community colleges.

HB 3120

CARRIED OVER FROM THE 03/28/2023 AGENDA: Requires Higher Education Coordinating Commission to conduct study to determine best method for connecting public higher education to workforce and economic development needs of Oregon.

HB 3427

CARRIED OVER FROM THE 03/28/2023 AGENDA: Requires public university to submit any proposed change in affiliation with athletic association, conference or organization with authority over intercollegiate sports to appropriate legislative committees for review.

HB 3456

CARRIED OVER FROM THE 03/28/2023 AGENDA: Establishes Sexual Misconduct Survey Council.

HB 3561

CARRIED OVER FROM THE 03/28/2023 AGENDA: Specifies that term "early childhood care and education" includes early childhood behavioral and mental health services for purposes of scholarships and grants awarded to ensure state has adequate supply of early childhood care and education professionals.

HB 3563

CARRIED OVER FROM THE 03/28/2023 AGENDA: Creates Oregon Youth Works Advisory Board to advise on and oversee implementation and alignment of youth workforce development programs for which Higher Education Coordinating Commission is responsible.

HB 3565

CARRIED OVER FROM THE 03/28/2023 AGENDA: Establishes Oregon Tribal Student Grant program.
