HB 3042

Limits terminations and rent increases for three years after tenants' housing is withdrawn from publicly supported housing.

## HB 2634

Defines "recreational vehicle park" for the purposes of residential tenancy law.

HB 3215 \*\*

HB 3482

Requires Department of Land Conservation and Development to study housing.
