SB 892 A

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to department's procurement authority and ability to provide down payment assistance.

SB 406 A

CARRIED OVER FROM THE 5/11/2023 MEETING: Requires certain cities and communities in Tillamook County to allow middle housing on residentially zoned lands, to adopt housing production strategies and to accommodate estimated housing needs upon lands inventoried as buildable lands.

SB 437 A

CARRIED OVER FROM THE 5/11/2023 MEETING: Allows specified production of food in planned community by lot owners and their tenants.

SB 1013

CARRIED OVER FROM THE 5/11/2023 MEETING: Requires counties to allow certain rural homeowners to site one recreational vehicle on their property.

SB 503 A

CARRIED OVER FROM THE 5/11/2023 MEETING: Eliminates requirement for unanimous consent of owners of affected lots or units in planned community when method of determining liability for common expenses or right to common profits is changed.
