Public Hearing

HB 2719

Requires Department of Justice to study services for crime victims.

HB 3114

Prohibits hotelkeeper or innkeeper from requiring qualified victim services program that facilitates reservation or rental of guest room in hotel or inn to disclose personal information of victim of domestic violence, sexual assault or stalking.

Work Session

HB 2676

Modifies Department of Justice crime victim compensation program.

HB 2732 **

**Subsequent Referral(s) to Ways and Means

Modifies allocation formula for grants to children's advocacy centers.

HB 2933 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Department of Justice for deposit into Oregon Domestic and Sexual Violence Services Fund.

HB 3018 **

**Subsequent Referral(s) to Ways and Means

Authorizes Department of Justice to assist victims of domestic violence and sexual assault with housing needs.
