HB 2535 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Department of Corrections to establish doula program for pregnant and postpartum adults in custody at Coffee Creek Correctional Facility.

HB 2731 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Oregon Criminal Justice Commission to establish, in collaboration with Department of Corrections, Family Preservation Project pilot program at Coffee Creek Correctional Facility.

HB3218

Authorizes remote attestation of certain wills.

SB

Modifies number of weeks notice to interested persons in decedent's estate must be published.

#### **Public Hearing**

HB 3275

Provides that supervision of certain misdemeanor offenders reverts to Department of Corrections if county opts out of providing correctional services.

HB 3294

Requires county clerk to replace recorded instrument with court-ordered version that redacts discriminatory language.

SB308 A

> Changes title of "small estate affidavit" to "simple estate affidavit." Modifies eligibility for simple estate affidavit to include estate of decedent dying testate if value of specific bequests does not exceed specified amount and residual beneficiary is decedent's inter vivos trust.
