#### Work Session

HB 2128

Replaces escrow deposit system required of tobacco product manufacturers who are nonparticipating manufacturers for purposes of Master Settlement Agreement with requirement of direct payments to state.

HB 2328 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Modifies definition of "oral or anal sexual intercourse" for purposes of sex crimes.

#### Public Hearing

HB 2931

Requires Oregon Liquor and Cannabis Commission to study cannabis.

*For the purpose of consideration of the -1 amendments only.*

HB 2950

Bars creditors' claims against decedents' estates if no petition for appointment of personal representative or small estate affidavit is filed within 18 months following decedent's date of death.

SB 310

Increases amount of civil penalty Attorney General may obtain for violation of antitrust statutes from \$250,000 to \$1 million.

SB 311

Modifies damages and penalties awarded for action for false claims.
