HB 2405

Requires that court dismissing charges due to defendant lacking fitness to proceed also order transport of defendant back to jurisdiction in which charges were initiated.

HB 3275

Provides that supervision of certain misdemeanor offenders reverts to Department of Corrections if county opts out of providing correctional services.

Public Hearing

HB 3213

Prohibits manufacturer from selling or offering to sell cosmetic developed through use of cosmetic animal test.

HB 3214

Prohibits person from using specified types of animals in traveling animal act.

HB 3571

Establishes immunity from prosecution for theft in first degree and civil liability for nonprofit animal rescue entity that takes possession of, keeps and disposes of cat or dog as provided in Act.

SB 306 A

Modifies statutes to allow for nonattorney associate members of the Oregon State Bar to practice law in certain scope of practice.
