HB 2006

CARRIED OVER FROM THE 4-3-2023 MEETING: Prohibits person under 21 years of age from possessing firearms with specified exceptions.

HB 2007

CARRIED OVER FROM THE 4-3-2023 MEETING: Authorizes governing bodies of certain public entities that own or control public building to adopt policy, ordinance or regulation or precluding affirmative defense for possession of firearms in public building and adjacent grounds by concealed handgun licensees.

HB 2323

CARRIED OVER FROM THE 4-3-2023 MEETING: Provides that culpable mental state applies to each material conduct element unless statutory language or legislative intent plainly indicates otherwise.

HB 3213

HB 3294

CARRIED OVER FROM THE 4-3-2023 MEETING: Requires county clerk to replace recorded instrument with court-ordered version that redacts discriminatory language.

HB 2364

Directs Oregon Criminal Justice Commission to study recidivism rates of persons convicted of property crimes, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

HB 2365

Directs Public Defense Services Commission to study ways to improve provision of public defense services within this state, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

HB 2374

Directs Department of Justice to study ways to improve provision of crime victim services, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

HB 2375

Requires Oregon Youth Authority to study its practices and procedures.

HB 2380

Requires Oregon State Bar to study rules of evidence.

HB 2388

Directs Oregon Criminal Justice Commission to study effect of payment of restitution on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

HB 2932

Requires Oregon Liquor and Cannabis Commission to study cannabis.
