#### Work Session

SB 317

Provides that requirement that certain hearsay statements of unavailable witnesses concerning acts of abuse must be supported by corroborative evidence applies in juvenile delinquency proceedings.

SB 529

Modifies legislative findings concerning alternative incarceration programs.

SB 577 A

Modifies when use of force upon minor child or student is justifiable and not criminal.

SB 618 A

Directs court to consider, when determining aggravation at sentencing, whether defendant was wearing body armor at time of crime.

SB 785 A

Allows parking in spaces regulated by out-of-service parking meters operated by public bodies unless notice prohibiting parking is posted.
