Public Hearing

SB 597

Directs certifying agencies to report annually to Oregon Criminal Justice Commission on victim helpfulness certification requests.

SB 699

Expands definition of "public safety officer" to include certain regulatory specialists as persons who may be eligible for benefit awards from Public Safety Memorial Fund.

SB 810

Reconciles and modifies penalties for certain offenses involving unmanned aircraft systems.
