Public Hearing

SB 292 B

Narrows, on temporary basis, applicability of requirement that members of district school board must file verified statement of economic interest to only those members of districts with specified number of students.

HB 2765

Grants to South Suburban Sanitary District exclusive right to use and sell treated wastewater discharged by district into Klamath River or tributaries.

HB 3183

Requires Oregon Liquor and Cannabis Commission to require applicant for cannabis-related license or license renewal to submit signed attestation that applicant will refrain from interfering with labor organizing efforts or submit attestation that applicant and labor organization that is certified to represent employees of applicant have entered into and will abide by terms of labor peace agreement.

HB 2468

CARRIED OVER FROM THE 5/9/2023 MEETING: Requires landlord to allow dwelling to be used as family child care home.

HB 3333

CARRIED OVER FROM THE 5/9/2023 MEETING: Permits Department of Human Services to require specified providers to submit corrective action plan in lieu of investigating report of suspected abuse of child in care in certain circumstances.

HB 3610

CARRIED OVER FROM THE 5/9/2023 MEETING: Establishes Task Force on Alcohol Pricing and Addiction Services.

SB 168 A

Expressly prohibits public employees, while on job during working hours or while otherwise working in official capacity, from promoting or opposing appointment, nomination or election of public officials.

HB 3031

Requires Department of Education to study matters related to ventilation and energy efficiency in schools.

HB 2572

Expands definition of "civil disorder" for purposes of crime of unlawful paramilitary activity.

HB 3254

Requires Higher Education Coordinating Commission to establish statewide semiconductor industry consortium for purpose of building robust, strategic partnerships between semiconductor industry, institutions of education, workforce organizations and community-based organizations.

HB 3308

Authorizes Oregon Liquor and Cannabis Commission to issue delivery permit to qualified applicant to deliver alcoholic beverages to final consumers.

HB 3608

Provides that, for purpose of specifying prevailing rate of wage for electrical workers, locality is geographical area within which each local union is exclusive representative for local union's membership, and collective bargaining agreement is collective bargaining agreement to which local union is party.
