Public Hearing

Please note: the public hearing on HB 2038 is scheduled to take testimony on the bill as amended by the -1 amendments.

HB 2038

Requires statement of economic interest to include certain information about sources of income for business in which public official or candidate, or member of household of public official or candidate, is officer, holds directorship or does business under if source of income has legislative or administrative interest and 10 percent or more of total gross annual income of business comes from that source of income.

Please note: the public hearing on HB 3073 is scheduled to take testimony on the bill as amended by the -3 amendments.

HB 3073

Prohibits Secretary of State and county clerks from disclosing as public record, or including on lists of electors, residence address of elector who is candidate for elected office or holder of elected office.

Work Session

HB 2004

Establishes ranked choice voting as voting method for selecting winner of nomination for and election to offices of President of United States, United States Senator, Representative in Congress, Governor, Secretary of State, State Treasurer and Attorney General.

HB 3031

Requires Department of Education to study matters related to ventilation and energy efficiency in schools.

SB 53

Adds members of household of candidate to list of persons who may not be employed to open ballot envelopes, handle ballots, prepare ballots for counting or count ballots.
