**Subsequent Referral(s) to Ways and Means

Extends sunset for credit for certified Opportunity Grant contributions.

SB 183 **

**Subsequent Referral(s) to Ways and Means

Establishes Purple Star School Program within Department of Education to recognize schools that provide certain support services to military-connected students.

SB 292

Requires Department of Education to conduct study to determine adequacy of education in public schools.

SB 272

Provides that student who legally entered United States as refugee, through special immigrant visa or under Compact of Free Association treaty between United States and Republic of Palau, Republic of the Marshall Islands or Federated States of Micronesia and who has not previously established residence in any state or territory of United States other than Oregon qualifies for exemption from nonresident tuition and fees at Oregon Health and Science University.

SB 427

Clarifies agency access to moneys in Early Learning Account.

SB 521

Aligns statutory language with constitutional language to require that corporate kicker be used to fund kindergarten through grade 12 public education.

SB 276

Increases amount person may be reimbursed for provision of vision screening to student.

SB 424

Prohibits post-secondary institutions of education that are based in Oregon from refusing to provide transcript to current or former student because student owes debt to institution.
