SB 279

Requires Teacher Standards and Practices Commission to conduct study to determine if state should enter into interstate agreement to encourage educator mobility.

SB 819

Modifies abbreviated school day program requirements.

SB 767

Limits scope by which public charter schools may conduct operations in school district that is not sponsor of public charter school.

SB 426 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Modifies requirements of Healthy and Safe Schools Plan related to integrated pest management.

SB 285 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Increases amounts of grants for school district facilities under certain grant programs.

SB 414

Requires school districts to prepare ventilation verification assessment and take certain actions based on recommendations that result from assessment.
