- SB 183 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Purple Star School Program within Department of Education to recognize schools that provide certain support services to military-connected students.
- SB 423  
Requires that faculty and nonfaculty staff members of governing board at public university are voting members of board.

#### Public Hearing

- SB 285 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 2/28/2023 AGENDA: Increases amounts of grants for school district facilities under certain grant programs.
- SB 518  
Specifies contract price at which apprentice utilization requirements apply to qualified contracts with institutions of higher education and school districts.
- SB 523  
Requires Higher Education Coordinating Commission plan regarding applied baccalaureate degrees to include name and type of applied baccalaureate degrees to be conferred.
- SB 458 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys from General Fund to Higher Education Coordinating Commission for allocation to Oregon State University to fund agricultural experiment station and branch stations, Oregon State University Extension Service and Forest Research Laboratory.
- SB 275  
Requires Department of Education, Teacher Standards and Practices Commission and Educator Advancement Council to conduct study to identify best means of improving alignment among state education agencies.
