- SB 54 ** **Subsequent Referral(s) to Tax Expenditures
Removes provisions of property tax exemption for community solar projects that restrict exemption to proportion owned by residential customers or leased by residential subscribers.
- SB 139 ** **Subsequent Referral(s) to Tax Expenditures
Creates sunset for rural renewable energy development zone exemption.
- SB 145 ** **Subsequent Referral(s) to Tax Expenditures
Creates sunset of tax exemption for property of certain cooperatives used to heat water by combustion of biomass.
