#### **Public Hearing**

SB 443

Requires electric companies to reimburse qualified customers up to \$250 for purchase price of backup power source when power shutoff is likely to occur and power shutoff will likely last for eight or more hours.

SB 444 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Environmental Quality to establish Recycling Innovators Grant Program. SB 546

Requires Oregon Health Authority to adopt and maintain list of designated high priority chemicals of concern used in cosmetic products and to periodically review and revise list.

#### Work Session

SB 64

Requires Department of Environmental Quality to study disposal of electric vehicle batteries and batteries used to store energy in wind or solar renewable energy facilities.
