525 ** SB

**Subsequent Referral(s) to Ways and Means

Directs Environmental Quality Commission to adopt standards prohibiting engine exhaust and evaporative emissions from new small nonroad engines beginning January 1, 2026, unless a later date is required by federal Clean Air Act.

SB 522 is scheduled solely for the purpose of reviewing proposed amendments that are posted on OLIS.

Work Session

SB 522

Changes name of "Oregon Global Warming Commission" to "Oregon Climate Action Commission." Modifies membership and duties of commission.

SB 543

Prohibits food vendor from using polystyrene foam container in sales of prepared food. 546 SB

Requires Oregon Health Authority to adopt and maintain list of designated high priority chemicals of concern used in cosmetic products and to periodically review and revise list.
