- SB 432 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 3-22-2023 MEETING: Requires Oregon Health Authority to develop, implement and administer program to support consumer engagement efforts aimed at increasing and optimizing consumer involvement in planning and decision-making surrounding the access to, and the delivery of, behavioral health services in this state.
- SB 624 ** **Subsequent Referral(s) to Ways and Means
Establishes certified community behavioral health clinic program in Oregon Health Authority.
- SB 607
Requires Oregon Health Authority to study membership of Pain Management Commission.
- SB 1044
Requires Oregon Health Authority to study access to behavioral health treatment.
- SB 1046
Expands network adequacy requirements to health benefit plans offered to large employers and modifies requirements.
- SB 490 ** **Subsequent Referral(s) to Ways and Means
Directs Oregon Medical Board to support alliance program for family medicine residency training programs in this state.
- SB 191
Requires Oregon Health Authority to study fee-for-service medical assistance recipients' access to health care providers in rural areas of this state.

Public Hearing

Please note: SB 1041, SB 1076, SB 1074, and SB 492 are scheduled solely for the purpose of hearing testimony from the people who previously signed up to testify at the meeting on 3-22-2023.

- SB 1041
CARRIED OVER FROM THE 3-22-2023 MEETING: Prohibits cost-sharing on certain health insurance coverage of supplemental and diagnostic breast examinations.

SB 1076

CARRIED OVER FROM THE 3-22-2023 MEETING: Requires licensed hospitals to include in hospital's discharge policy specified procedures for discharge of homeless patients.

SB 1074 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-22-2023 MEETING: Directs Oregon Health Authority to administer two-year demonstration project in two counties to test whether expanding scope of compensable services provided by community health workers can improve outcomes for low-income families and children at risk of entering foster care system.

SB 192

Requires Oregon Health Authority to study ways to lower cost of prescription drugs.

SB 608

Prohibits insurers offering policies or certificates of health insurance and pharmacy benefit managers from requiring claim for reimbursement of prescription drug to include modifier or other indicator that drug is 340B drug.

SB 408 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Health Authority to establish process to receive and review health care profession scope of practice requests and impact statements.

SB 492

CARRIED OVER FROM THE 3-22-2023 MEETING: Imposes new requirements on the determination of health services to be provided in state medical assistance program.
