#### **Public Hearing**

HB 2395 A

Allows specified persons to distribute and administer short-acting opioid antagonist and distribute kits.

HB 2584 A

Specifies physician assistant scope of practice and duties of care when practicing medicine.

HB 2627 A

Removes one member who has degree of Doctor of Medicine and adds one member who is physician assistant to membership of Oregon Medical Board.

HB 3008 A

CARRIED OVER FROM THE 4-19-2023 MEETING: Prohibits Oregon Board of Dentistry from requiring applicant for certification as dental assistant to pass written examination.
