#### **Work Session**

HB 2421 A

CARRIED OVER FROM THE 5-8-2023 MEETING: Directs Health Licensing Office to establish guidelines for professional methods and procedures used by registered behavior analysis interventionists.

HB 3008 A

Limits ability of insurers offering dental benefit to require reimbursement of claims by credit card or electronic funds transfer.

## **Public Hearing and Work Session**

HB 2286 A

Requires Oregon Health Authority to maintain process to identify claims eligible for enhanced federal match for services provided by nontribal providers that have written care coordination agreement with Indian health care provider and, if enhanced federal match is available from Centers for Medicare and Medicaid Services, return to Indian health care provider portion of enhanced federal match.

HB 2420 A

Directs Oregon Health Authority to designate work group to propose options for equitable access to birth and death certificates throughout state and equitable fee revenue to maintain and improve vital records system.

HB 3258 A

Requires pharmacy to report dispensation of prescription drugs classified in schedules II through V under federal Controlled Substances Act to electronic system established for monitoring and reporting prescription drugs when drug is prescribed and dispensed to individual for use by individual or individual's animal.
