### **Public Hearing**

606 \*\* SB

\*\*Subsequent Referral(s) to Ways and Means

Establishes Nonprofit Workforce Retention Fund in State Treasury, separate and distinct from General Fund, from which Employment Department must provide grants to qualifying nonprofit organizations for purpose of increasing compensation of and reducing turnover among employees of each recipient nonprofit organization.

SB

Requires that whenever notice of founded disposition of child abuse is delivered to perpetrator, notice must also be delivered to perpetrator's attorney, if applicable.

Prohibits Department of Human Services from disclosing records and reports related to child abuse investigations to certain entities unless court finds report of abuse is founded.

SB186

> Increases amount of monthly child support passed through to families participating in temporary assistance for needy families program.

SB823

> Requires disclosure, in response to public records request, of reports of investigations of child abuse occurring at specified state-authorized programs.

SB1024

> Modifies provisions regarding retention of records of incidents involving the use of restraints or seclusion of children in care and students in public education programs.

Prohibits use of public funds for out-of-state residential placement of students.

\*\*Subsequent Referral(s) to Ways and Means

Requires closed-captioned television receivers in public areas within places of public accommodation to display closed captioning unless exception applies.

SB 573

Directs Center for Health Statistics to enter name of parent on original record of live birth when paternity or parentage has been determined under certain circumstances.

SB 210

Requires Department of Human Services to study exceptions to mandatory abuse reporting requirements of department employees who provide assistance to domestic violence victims.

SB 576 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Department of Human Services to administer program to provide medical assistance to employed individuals with disabilities without regard to individuals' income or resources.
