Public Hearing

SB 188

Repeals provision prohibiting court from excluding admissible evidence on grounds evidence was obtained in violation of statute except in specified circumstances.

SB 955

Appropriates moneys from General Fund to support implementation of AgriStress Helpline in Oregon.

HB 2645 A

Increases penalties for possession of certain amounts of fentanyl.

Work Session

SB 212

Makes confidential and exempts from discovery and public records certain communications and information conveyed during peer support check-in sessions with Oregon Youth Authority employees.

SB 313

Directs court to take into consideration child's preferences when making best interests determination for purposes of child custody determinations.

SB 766 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Criminal Justice Commission to award noncompetitive grants through Illegal Marijuana Market Enforcement Grant Program to Department of State Police for specified purposes related to unlawful marijuana cultivation or distribution operations.

SB 867

Provides that witness is unavailable for purposes of hearsay rules if witness is absent from hearing and proponent of statement has established that party against whom statement is offered engaged in certain conduct that caused witness to be unavailable.

Note change: SB 955, SB 212 and SB 766 added.
