## **Public Hearing and Work Session**

SB 185

Requires Department of Justice to study immigration in this state.

SB 320

Provides that person sentenced to mandatory minimum sentence under Ballot Measure 11 (1994), for crime other than murder, who has not been previously sentenced under measure is eligible for reduction in sentence for appropriate institutional behavior and participation in certain programming unless otherwise ordered by court for substantial and compelling reasons.

SB<sup>1</sup> 372

Requires State Department of Agriculture to study animals.

## SB 188

CARRIED OVER FROM THE 3-30-2023 MEETING: Repeals provision prohibiting court from excluding admissible evidence on grounds evidence was obtained in violation of statute except in specified circumstances.

SB 319

Provides that person who contracts with public body to provide services for purposes of community restoration or to restore fitness to proceed is state officer, employee or agent for purposes of indemnification under Oregon Tort Claims Act under certain circumstances.

SB 321

Creates process by which person convicted or found guilty except for insanity as result of nonunanimous jury verdict may file petition for post-conviction relief within one year of effective date of Act.

SB 337

Directs Public Defense Services Commission to study ways to improve provision of public defense services within this state, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

#### SB 348

CARRIED OVER FROM THE 3-30-2023 MEETING: Directs Department of Justice to study ways to address unlawful possession of firearms, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB 353

Requires Oregon Liquor and Cannabis Commission to study cannabis.

SB 355

CARRIED OVER FROM THE 3-30-2023 MEETING: Requires Oregon State Bar to study attorneys.

#### SB 376

CARRIED OVER FROM THE 3-30-2023 MEETING: Requires Department of Consumer and Business Services to study insurance.

#### SB 380

CARRIED OVER FROM THE 3-30-2023 MEETING: Requires Judicial Department to study protective proceedings.

#### SB 413 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Public Defense Services Student Loan Repayment Assistance Program in Oregon State Bar to provide forgivable loans to eligible public defense attorneys for outstanding student loans.

SB 470

> Prohibits denial of medical assistance on basis that individual under 19 years of age is in detention pending adjudication.

#### SB 527

CARRIED OVER FROM THE 3-30-2023 MEETING: Allows gun dealer or person transferring firearms, firearm accessories, ammunition or ammunition components for purchase at gun show, or business engaged in repairing or servicing firearms to establish minimum age of 21 years for such purchases, repairs or services.

### SB 528 \*\*

\*\*Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 3-30-2023 MEETING: Modifies provisions relating to protective proceedings.

SB 554

Creates process by which person may file post-conviction relief petition due to currently available relevant forensic scientific evidence at any time after conviction.

SB 614

CARRIED OVER FROM THE 3-30-2023 MEETING: Establishes exception, for video cameras worn by law enforcement officer, to prohibition on law enforcement agency collecting or maintaining information about person's political, religious or social views or activities.

### SB 619 \*\*

\*\*Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 3-30-2023 MEETING: Permits consumers to obtain from a controller that processes consumer personal data confirmation as to whether controller is processing consumer's personal data and categories of personal data controller is processing, list of specific third parties to which controller has disclosed consumer's personal data and copy of all of consumer's personal data that controller has processed or is processing.

CARRIED OVER FROM THE 3-30-2023 MEETING: Directs Judicial Department to develop and implement automated system that identifies convictions, arrests, citations, charges and judgments of guilty except for insanity that are eligible to be automatically sealed.

#### SB 780

Creates offense of unlawful fender height modifications.

#### SB 808

CARRIED OVER FROM THE 3-30-2023 MEETING: Modifies membership and other provisions relating to the Commission on Statewide Law Enforcement Standards of Conduct and Discipline. SB 816

Modifies duration of certain restraining orders when restrained person requests hearing within relevant time frame.

#### SB 848

CARRIED OVER FROM THE 3-30-2023 MEETING: Extends provision relating to indemnification provisions in construction agreements to all types of damages.

#### SB 891

CARRIED OVER FROM THE 3-30-2023 MEETING: Modifies provisions relating to Oregon Death with Dignity Act.

SB 909

Updates and modernizes laws that govern formation, governance, operations and conversion of limited liability companies in this state and relations among members, managers and third parties with respect to limited liability companies in this state.

#### SB 915

Creates Deadly Force Prosecutions Unit within Criminal Justice Division of Department of Justice.

#### SB 953

CARRIED OVER FROM THE 3-30-2023 MEETING: Changes title of "district medical examiner" to "county medical examiner." Changes title of "medical-legal death investigator" to "medicolegal death investigator."

Eliminates partial reimbursement by state of certain county autopsy expenditures.

#### SB 957

Expands types of prior convictions that increase offense level for crime of public indecency. SB 974

CARRIED OVER FROM THE 3-30-2023 MEETING: Creates crime of sexual assault by fraudulent representation.

### SB 1052

CARRIED OVER FROM THE 3-30-2023 MEETING: Modifies crimes related to involuntary servitude and human trafficking.

### SB 1060

CARRIED OVER FROM THE 3-30-2023 MEETING: Modifies definition of "physical injury," for purposes of Oregon Criminal Code, to include physical trauma.

#### SB 1061

CARRIED OVER FROM THE 3-30-2023 MEETING: Directs Oregon Cannabis Commission, Oregon Health Authority, Oregon Liquor and Cannabis Commission and Department of Revenue to work collaboratively to ensure access to cannabis for Oregonians.

#### SB 1070

Requires sentencing court to consider as mitigation evidence whether defendant was subjected to domestic abuse that was contributing factor in criminal behavior.
