SB 185

Requires Department of Justice to study immigration in this state.

SB 188

CARRIED OVER FROM THE 4-3-2023 MEETING: Repeals provision prohibiting court from excluding admissible evidence on grounds evidence was obtained in violation of statute except in specified circumstances.

SB 319

Provides that person who contracts with public body to provide services for purposes of community restoration or to restore fitness to proceed is state officer, employee or agent for purposes of indemnification under Oregon Tort Claims Act under certain circumstances.

SB 321

CARRIED OVER FROM THE 4-3-2023 MEETING: Creates process by which person convicted or found guilty except for insanity as result of nonunanimous jury verdict may file petition for post-conviction relief within one year of effective date of Act.

SB 348

CARRIED OVER FROM THE 4-3-2023 MEETING: Directs Department of Justice to study ways to address unlawful possession of firearms, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB 353

Requires Oregon Liquor and Cannabis Commission to study cannabis.

Directs Oregon Criminal Justice Commission to study effect of sentencing types on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB 470

CARRIED OVER FROM THE 4-3-2023 MEETING: Prohibits denial of medical assistance on basis that individual under 19 years of age is in detention pending adjudication.

SB 614

CARRIED OVER FROM THE 4-3-2023 MEETING: Establishes exception, for video cameras worn by law enforcement officer, to prohibition on law enforcement agency collecting or maintaining information about person's political, religious or social views or activities. 697

SB 69

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies process for setting aside convictions and guilty except for insanity judgments.

CARRIED OVER FROM THE 4-3-2023 MEETING: Updates and modernizes laws that govern formation, governance, operations and conversion of limited liability companies in this state and relations among members, managers and third parties with respect to limited liability companies in this state.

SB 974

CARRIED OVER FROM THE 4-3-2023 MEETING: Creates crime of sexual assault by fraudulent representation.

SB 1052

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies crimes related to involuntary servitude and human trafficking.

SB 1060

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies definition of "physical injury," for purposes of Oregon Criminal Code, to include physical trauma.

SB 1061

CARRIED OVER FROM THE 4-3-2023 MEETING: Directs Oregon Cannabis Commission, Oregon Health Authority, Oregon Liquor and Cannabis Commission and Department of Revenue to work collaboratively to ensure access to cannabis for Oregonians.
