SB 185

Requires Department of Justice to study immigration in this state.

SB188

> CARRIED OVER FROM THE 4-3-2023 MEETING: Repeals provision prohibiting court from excluding admissible evidence on grounds evidence was obtained in violation of statute except in specified circumstances.

SB319

> Provides that person who contracts with public body to provide services for purposes of community restoration or to restore fitness to proceed is state officer, employee or agent for purposes of indemnification under Oregon Tort Claims Act under certain circumstances.

SB321

> CARRIED OVER FROM THE 4-3-2023 MEETING: Creates process by which person convicted or found guilty except for insanity as result of nonunanimous jury verdict may file petition for post-conviction relief within one year of effective date of Act.

SB348

> CARRIED OVER FROM THE 4-3-2023 MEETING: Directs Department of Justice to study ways to address unlawful possession of firearms, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB353

Requires Oregon Liquor and Cannabis Commission to study cannabis.

SB393

> Directs Oregon Criminal Justice Commission to study effect of sentencing types on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB470

> CARRIED OVER FROM THE 4-3-2023 MEETING: Prohibits denial of medical assistance on basis that individual under 19 years of age is in detention pending adjudication.

SB 614

CARRIED OVER FROM THE 4-3-2023 MEETING: Establishes exception, for video cameras worn by law enforcement officer, to prohibition on law enforcement agency collecting or maintaining information about person's political, religious or social views or activities.

SB 697

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies process for setting aside convictions and guilty except for insanity judgments.

SB 698 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-3-2023 MEETING: Directs Judicial Department to develop and implement automated system that identifies convictions, arrests, citations, charges and judgments of guilty except for insanity that are eligible to be automatically sealed.

SB 780

CARRIED OVER FROM THE 4-3-2023 MEETING: Creates offense of unlawful fender height modifications.

SB 808

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies membership and other provisions relating to the Commission on Statewide Law Enforcement Standards of Conduct and Discipline.

SB 891

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies provisions relating to Oregon Death with Dignity Act.

SB 909

CARRIED OVER FROM THE 4-3-2023 MEETING: Updates and modernizes laws that govern formation, governance, operations and conversion of limited liability companies in this state and relations among members, managers and third parties with respect to limited liability companies in this state.

SB 974

CARRIED OVER FROM THE 4-3-2023 MEETING: Creates crime of sexual assault by fraudulent representation.

SB 1052

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies crimes related to involuntary servitude and human trafficking.

SB 1060

CARRIED OVER FROM THE 4-3-2023 MEETING: Modifies definition of "physical injury," for purposes of Oregon Criminal Code, to include physical trauma.

SB 1061

CARRIED OVER FROM THE 4-3-2023 MEETING: Directs Oregon Cannabis Commission, Oregon Health Authority, Oregon Liquor and Cannabis Commission and Department of Revenue to work collaboratively to ensure access to cannabis for Oregonians.

SB 1070

Requires sentencing court to consider as mitigation evidence whether defendant was subjected to domestic abuse that was contributing factor in criminal behavior.

Placeholder Bills that do not currently have planned amendments

SB 332

Requires Oregon Health Authority to study access to behavioral health treatment in rural and medically underserved areas of this state.

SB 341

Requires State Court Administrator to study courts.

SB 347

Requires Oregon Youth Authority to study issues related to youth.

SB 356

Requires Oregon State Bar to study attorneys.

SB 371

Requires State Court Administrator to study court lawsuits.

SB 385

Directs Oregon Criminal Justice Commission to study effect of different types of sentences on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB 388

Deletes obsolete reference to definition of "alternative fuel vehicle." Defines "alternative fuel vehicle."

SB 389

Directs Department of Justice to study ways to address domestic violence, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.

SB 390

Requires Oregon Health Authority to study availability of mental health treatment in rural areas of Oregon.
