HB 2279

Repeals residency requirement in Oregon Death with Dignity Act.

HB 2372 A

Modifies purpose and duties of Youth Development Council and Youth Development Division.

HB 2405 A

Requires that court dismissing charges involving orders of commitment due to defendant lacking fitness to proceed also order transport of defendant back to jurisdiction in which charges were initiated.

HB 2594

Modifies penalties for throwing lighted material onto certain property.

HB 2915 A

Prohibits retail pet store from offering to sell or selling dogs or cats.
