### **Public Hearing and Possible Work Session**

SB 184

Modifies employer child support reporting requirements to include payments made to independent contractors.

SB 538

Permits state agency to accept credit card as payment for charge or fee state agency imposes or collects for goods or services state agency provides to individual who is member of public and to add surcharge to amount person tenders to offset fees charged to state agency for accepting credit card as payment.

### Public Hearing

### SB 224

Updates and modernizes statutes that regulate practice of architecture in this state to conform with actual current practice of architecture.

SB 594

Requires payment of prevailing rate of wage for demolition of or removal of hazardous waste from road, highway, building, structure or improvement in public improvement contract that uses \$750,000 or more of public funds or that occurs on real property that state agency owns, including demolition or removal of hazardous waste that occurs in connection with construction, reconstruction, renovation or painting of road, highway, building, structure or improvement.

SB 842 \*\* \*\*Subsequent Referral(s) to Ways and Means Changes expenditure limitation for grant to Port of Port Orford for seafood hub redevelopment project to biennium beginning July 1, 2023.

### SB 853

Prohibits state from paying costs of travel to or from Oregon for employee in state service who telecommutes from principal worksite outside this state.
