SB 592

CARRIED OVER FROM THE 2-21-2023 MEETING: Requires Director of Department of Consumer and Business Services to conduct comprehensive inspections of fixed place of employment when occupational death or three or more willful or repeated violations have occurred.

Public Hearing and Possible Work Session

SB 418

Requires subject employers to adopt policy allowing subject workers paid time off during shift to receive medical services related to worker's compensable injury or occupational disease.

HB 2110 A

Removes requirement for certain state agencies to withhold moneys from municipal corporations that fail to file audit reports with Secretary of State.

HB 2523

Decreases number of course hours required before person may sit for certified public accountant exam.

SB 850

Requires public body that procures construction services for certain qualified projects that use \$750,000 or more in funds of public agency or moneys made available to state under federal American Rescue Plan Act of 2021 to enter into project labor agreement that, at minimum, provides for payment of wages at or above prevailing rate of wage, to use apprentices to perform at least 15 percent of work hours that workers in apprenticeable occupations perform on project and to establish and execute plan for outreach, recruitment and retention of women, minority individuals and veterans to perform work on project.
