SB1047

> Raises contract price threshold under which contracting agency may apply certain solicitation and procurement methods for public contracts.

SB 631

CARRIED OVER FROM THE 3/23/2023 MEETING: Permits employees of certain state agencies to refuse to work additional mandatory overtime shift scheduled by employer when employee has already worked mandatory overtime in same month.

#### **Public Hearing and Work Session**

SB 418

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires subject employers to adopt policy allowing subject workers paid time off during shift to receive medical services related to worker's compensable injury or occupational disease.

SB571

> Requires employer to offer contribution to ABLE account in lieu of contribution to retirement account.

SB845

> CARRIED OVER FROM THE 3/23/2023 MEETING: Modifies procedures required for binding arbitration for certain public employees.

SB851

> Requires Bureau of Labor and Industries to study matters relating to psychological abuse occurring in workplaces in Oregon.

# AGENDA (cont.) March 28, 2023

SB 881

CARRIED OVER FROM THE 3/23/2023 MEETING: Provides that client company that is furnished workers by worker leasing company is responsible for employer duties under paid family and medical leave insurance program with respect to workers leased to client company.

SB 907

Provides employee with right to refuse to perform task assigned by employer under certain circumstances.

SB 925

Makes unlawful practice for employer or employment agency to advertise job, promotion or transfer opportunity without disclosing pay range and employment benefits in job posting.

SB 987

Requires Public Employees Retirement Board to study approaches to lowering employer contribution rate paid by charter schools under Public Employees Retirement System.

SB 999

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires Bureau of Labor and Industries to study issues relating to different leave laws under which individuals may take time off of work for qualifying reasons.

SB 30

Requires Bureau of Labor and Industries, in consultation with Employment Department to conduct study that identifies apprenticeship opportunities in this state and evaluates best practices for keeping up-to-date list of available opportunities on webpages of bureau and department.

SB 32

Permits Oregon Department of Administrative Services to study public contracting law.

SB 33

Requires Bureau of Labor and Industries to study issues related to internal staffing at bureau.

SB 34

Authorizes Oregon Business Development Department to survey state loan and grant programs for economic development.

SB 35

Permits Bureau of Labor and Industries to study issues relating to employment in this state.

SB 36

Authorizes Director of Employment Department to study alternative arrangements by which employers may make tax payments required under unemployment insurance law.

SB 37

Permits Bureau of Labor and Industries to study issues relating to unlawful employment practices that occur in Oregon.

SB 52

Requires Bureau of Labor and Industries to study issues related to compliance with employment laws of this state.

SB 591

Requires Bureau of Labor and Industries to study issue of labor trafficking in this state.

SB 593

Requires Employment Department to study issues related to family and medical leave insurance program.

Please Note: The following bill is scheduled solely for the purpose of moving it to the Senate Committee on Rules.

# AGENDA (cont.) March 28, 2023

SB 1067

Modifies definition of "employment relations" to exclude standards, requirements or procedures relating to body-worn cameras for purposes of law enforcement officer collective bargaining.
