#### Work Session

HB 2274 A

CARRIED OVER FROM THE 5/2/2023 MEETING: Permits Director of Department of Consumer and Business Services to make any proper inquiry of person or matter connected with offering, purchasing or selling any security or conducting securities business and requires person to reply promptly and truthfully to inquiry.

HB 2870 A

CARRIED OVER FROM THE 5/2/2023 MEETING: Requires contracting agency to accept from contractors bonds in lieu of retainage for construction projects and public improvement contracts.

HB 3213 A

CARRIED OVER FROM THE 5/2/2023 MEETING: Prohibits manufacturer from selling or offering to sell cosmetic developed through use of cosmetic animal test.

#### Possible Work Session

HB 3471 A

CARRIED OVER FROM THE 5/2/2023 MEETING: Makes unlawful employment practice for employer to request or require worker to enter into settlement or agreement disposing of workers' compensation claim that bars worker from seeking further employment with employer unless such provision is first requested by worker.

HB 2057 A

Makes contractor jointly and severally liable in civil or administrative action for unpaid wages of unrepresented employee of subcontractor at any tier.

HB 2921 A

Requires hospitals to file certain reports showing demographics of hospitals' workforces with Commissioner of the Bureau of Labor and Industries for posting to Bureau of Labor and Industries' website.

### Public Hearing and Possible Work Session

HB 2283 A

PUBLIC HEARING CARRIED OVER FROM THE 5/2/2023 MEETING: Modifies provisions relating to public employee retirement.

HB 3028 A

PUBLIC HEARING CARRIED OVER FROM THE 5/2/2023 MEETING: Prohibits employer from requiring employee to use vacation, sick or annual leave for time spent by employee as appointed member of state board or commission.

HB 3532

PUBLIC HEARING CARRIED OVER FROM THE 5/2/2023 MEETING: Allows Arts Program to use up to five percent of value of Trust for Cultural Development Account for certain administrative purposes.

### Public Hearing

HB 2556 A

CARRIED OVER FROM THE 5/2/2023 MEETING: Provides requirements for employer deductions for erroneous overpayments of wages for employees who are not subject to collective bargaining agreement.
