- SB 530 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 3-27-23 MEETING: Establishes state policy regarding natural climate solutions.
- SB 1012  
CARRIED OVER FROM 3-27-23 MEETING: Provides for homestead rebuilt by same owner on same lot to replace homestead destroyed by September 2020 wildfires to temporarily have frozen assessed value equal to destroyed homestead's assessed value for 2020-2021 property tax year.
- SB 873  
CARRIED OVER FROM 3-27-23 MEETING: Allows Department of Land Conservation and Development, Department of State Lands or Department of Transportation to allow bioengineering to protect coastal resources.
- SB 80  
Requires State Forestry Department to study wildfire.
- SB 643  
Modifies provisions relating to sales of homemade foods.

#### Public Hearing and Possible Work Session

- SB 398  
Requires State Department of Agriculture to study confined animal feeding operations.
