SB 292 A

Narrows applicability of requirement that members of district school board must file verified statement of economic interest to only those members of districts with specified number of students or districts that are sponsors of virtual public charter schools.

SB 585

Allows otherwise qualified person who becomes United States citizen less than 180 days before date of primary election to file for and be elected to office of precinct committeeperson, if person registers as member of major political party by filing deadline.
