## SB 1032 \*\*

Establishes higher education grant program for qualified dependents of current Oregon National Guard members who are eligible to continue to serve in Oregon National Guard for at least six additional years.

### SB 1033

Defines "active service," "active service of the state" and "state active duty."

Expands authority of Adjutant General, with approval of Governor, to order members of organized militia into active service of the state.

### SB 1034

Directs Department of Education to make biennial transfer to Oregon Military Department from State School Fund for purpose of paying costs of educational services provided through programs operated by military department for at-risk youth.
