CARRIED OVER FROM THE 3-21-2023 MEETING: Establishes Task Force on Reparations and directs task force to study and develop proposals for financial and nonfinancial reparations for Oregonians of African-American descent, develop appropriate methods for educating public about task force findings and recommend appropriate remedies based on task force findings.

SB 884 **

**Subsequent Referral(s) to Tax Expenditures

CARRIED OVER FROM THE 3-21-2023 MEETING: Grants higher property tax exemption for property of veterans with disabilities.

SB 935

Prohibits landlords from denying application for tenancy based on certain rental or financial screening or admissions criteria if applicant is refugee from Ukraine.

SB 994

Modifies who may be appointed as temporary Assistant State Judge Advocates from officers of organized militia to members of organized militia who are members in good standing of Oregon State Bar.

SB 1032 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 3-21-2023 MEETING: Establishes higher education grant program for qualified dependents of current Oregon National Guard members who are eligible to continue to serve in Oregon National Guard for at least six additional years.
