SUMMARY

Creates crime of unlawful kangaroo exchange. Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both. Adds crime to list of circumstances declared to be nuisance per se and to list of offenses for which instrumentalities of crime may be criminally forfeited.

A BILL FOR AN ACT

2 Relating to kangaroos; creating new provisions; and amending ORS 105.597
3 and 131.602.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) As used in this section, “kangaroo” means an**
6 **Osphranter rufus commonly known as red kangaroo, Macropus**
7 **giganteus commonly known as eastern grey kangaroo, Macropus**
8 **fuliginosus commonly known as western grey kangaroo or Osphranter**
9 **robustus commonly known as the common wallaroo.**

10 **(2) A person commits the crime of unlawful kangaroo exchange if**
11 **the person purchases, receives, sells, transfers or otherwise exchanges**
12 **for commercial purposes any part of a dead kangaroo or any product**
13 **containing a part of a dead kangaroo.**

14 **(3) Violation of subsection (2) of this section, or any rule**
15 **promulgated pursuant thereto, is a Class A misdemeanor when the**
16 **offense is committed with a culpable mental state as defined in ORS**
17 **161.085.**

18 **SECTION 2. ORS 105.597 is amended to read:**

14 equine, both as defined in ORS 167.310, are present and have been left with-

17 carrying out any of the following activities, whether or not carried out with
18 a particular mental state:

19 (a) Training or keeping an animal for use in an exhibition of fighting as
20 defined in ORS 167.355.

21 (b) Preparing for, occupation for, promoting, conducting or participating
22 in an exhibition of fighting as defined in ORS 167.355.

23 (c) Possessing, keeping, breeding, training, buying, selling or offering for
24 sale a fighting dog as defined in ORS 167.360.

25 (d) Promoting, conducting, participating in or performing services in
26 furtherance of a dogfight as defined in ORS 167.360.

27 (e) Occupation, keeping or use of the place for a dogfight as defined in
28 ORS 167.360.

29 (f) Exchanging for commerce raw fur of a domestic cat or dog as defined
30 in ORS 167.390, or products that include the fur of a domestic cat or dog, if
31 the fur is obtained through a process that kills or maims the domestic cat

1 or dog.

2 (g) Possessing, keeping, rearing, training, buying, selling or offering for
3 sale a fighting bird as defined in ORS 167.426.

4 (h) Promoting, conducting, participating in or performing services in
5 furtherance of a cockfight as defined in ORS 167.426.

6 (i) Occupation, keeping or use of the place for a cockfight as defined in
7 ORS 167.426.

8 **(j) Engaging in an unlawful kangaroo exchange as defined in sec-**
9 **tion 1 of this 2023 Act.**

10 (4) Any place being used on a continuous, regular or sporadic basis for
11 carrying out any of the following activities:

12 (a) Sexual assault of an animal as described in ORS 167.333.

13 (b) Possession of dogfighting paraphernalia as described under ORS
14 167.372.

15 (c) Selling or offering for sale equipment other than paraphernalia de-
16 scribed in paragraph (b) of this subsection with the intent that the equipment
17 be used to train a fighting dog as defined in ORS 167.360.

18 (d) Possessing, controlling or otherwise having charge at the same time
19 of more than 50 sexually intact dogs that are two or more years of age for
20 the primary purpose of reproduction.

21 (e) Manufacturing, buying, selling, bartering, exchanging, possessing or
22 offering for sale a gaff or slasher as those terms are defined in ORS 167.426,
23 or other sharp implement designed for attachment to the leg of a fighting
24 bird as defined in ORS 167.426, with the intent that the gaff, slasher or other
25 sharp implement be used in a cockfight as defined in ORS 167.426.

26 (f) Manufacturing, buying, selling, bartering, exchanging, possessing or
27 offering for sale equipment other than equipment described in paragraph (e)
28 of this subsection with the intent that the equipment be used to train or
29 handle a fighting bird as defined in ORS 167.426 or to enhance the fighting
30 ability of a fighting bird.
