Subject: 2023 Committee Bill Summary

SB 80 (LC 2226) would require the Department of Forestry to study wildfire. Placeholder bill relating to wildfire.

SB 81 (LC 2227) would require the Department of Forestry to study incentivizing landowners to reduce wildfire risk. Placeholder bill relating to incentivizing landowners to reduce wildfire risk.

SB 82 (LC 2470) would prohibit an insurance company from using the statewide wildfire risk map as a basis for canceling a policy or increasing a premium.

SB 83 (LC 2476) would provide that a local government that adopted before July 19, 2021 and continues to enforce wildfire hazard mitigation building code standards is not subject to any subsequent update to section R327 of the Oregon Residential Specialty Code.

SB 84 (LC 2487) would require the State Marine Board to study issues related to safe operation of motorboats. Placeholder bill relating to motorboats.

SB 85 (LC 2491) would require the Department of Agriculture to study confined animal feeding operations. Placeholder bill relating to confined animal feeding operations.

SB 86 (LC 2504) would impose a limit on the exempt use of surface water for livestock watering at large concentrated animal feeding operations.

SB 87 (LC 2516) would instruct the OSU Extension Service to expand the Center for Small Farms and Community Food Systems by five extension positions. Would direct the Oregon Business Development Department to conduct a market analysis of the state's small-scale organic products sector.

SB 88 (LC 2523) would require certain agencies to develop a natural and working lands net carbon sequestration and storage inventory and metrics, and to monitor progress advancing related goals and policies. Would also require the study of related workforce and economic

development potential and would establish a natural and working lands advisory committee to the Oregon Global Warming Commission.

SB 89 (LC 3132) would require the Department of Agriculture to study aquaculture. Placeholder bill relating to aquaculture.
