# **Background**

- Oregon voters passed Measure 110 in November 2020
  - Decriminalized possession of substances for personal use
  - Created a health-based approach to addiction
- Legislature created Oversight and Accountability Council (OAC) of community members with lived experience (SB 755, 2021)
- OAC directs Measure 110 implementation and makes all grant funding decisions
- OHA provides guidance to the OAC and administers grants



# Key Values of Oversight and Accountability Council

- All treatment should be low barrier and have harm reduction philosophy
  - Treatment is what you want, when you want it
- Prioritize culturally specific, culturally responsive, and inclusive programs
- Housing is Health
  - Prioritizing both supportive housing (low barrier housing first) and recovery housing (sober and drug free housing)
- Includes reducing drug-related harm and supporting services for individuals who are actively using drugs, including those who are not seeking treatment or recovery



### Implementation Update

- As of January 2023, \$291.4 million spent or obligated
- 42 Behavioral Health Resource Networks (BHRNs) in all 36 counties
  - Each BHRN must offer screenings, assessments, peer services, low-barrier
     SUD treatment, harm reduction, housing, and supported employment
     services
- 233 Access to Care (ATC) grant agreements and 11 Tribal partners
  - M110 Grant Compliance Team performing compliance checks and technical support
  - Extensions to current BHRN grant agreements will provide program and fiscal stability and continuity of care for service recipients through 2023-25 biennium

# M110 BHRN Partner Analysis

The 233 grant agreements & 11 Tribal organizations each provide a unique mix of services designed for the populations they serve.

### **Grant Monitoring and Compliance**

- OAC and OHA now begin the important step of monitoring grantee compliance through previously established processes:
  - Grantees to report service data and fiscal data quarterly
  - Grantees to submit their service delivery policies and procedures by April 13
  - Performance audits and reviews by Oregon Secretary of State
  - OHA certification of community health workers, peer wellness specialists, and peer support specialists working within the BHRNs
  - OHA certification of outpatient substance use disorders treatment and recovery programs
  - Complaint intake process
