To protect animal health and welfare, public health, and consumers of veterinary services.


#### **Historical Context**

The Veterinary Medical Examining Board was established in 1903 to test, license, monitor and regulate practitioners of veterinary medicine in the state. The Board works in the interest of animal health and welfare, public health, and consumers of veterinary services. The Board's authority comes from the Veterinary Practice Act, Chapter 686 of the Oregon Revised Statutes and Chapter 875 of the Oregon Administrative Rules.


## **OVMEB** Organizational Chart

### Licensee By Year




### Licensee Geographical Demographics

**Veterinarians:** 43% practice within tri-counties (Clackamas, Multnomah, Washington Counties); 33% practice in secondary urban counties (Benton, Deschutes, Jackson, Lane, Marion); 24% practice in remaining outlying, rural, counties.

**Vet Interns:** 28% practice within tri-county area; 45% practice within secondary urban counties; 27% practice within rural counties.

**Certified Vet Techs:** 50% practice within tri-county area; 28% practice within secondary urban counties; 22% practice within rural counties.

### Key Performance Measures (KPMs)

- KPM #1: Public Protection Average time from receipt of a new complaint to completion of the investigation.
  - OVMEB has not met this target for the current reporting period. OVMEB has been experienced a near doubling of complaints within the last two years. We are working these cases and are pursuing hiring another investigator and have included a request for a second investigator position as a Policy Option Package within our 2023-25 Agency Request Budget.
- KPM #2: Public Protection Percent of decisions not contested, appealed, and/or upheld on appeal.
  - OVMEB has met and exceeded this this 95% target every year but the measure's current wording may lead to general, unanticipated abuses and results counter to public protection: possible reluctance to move forward with discipline or litigation on cases that warrant such action; closing cases prematurely or before board review; or settling cases that should be more fully adjudicated.

### Key Performance Measures (KPMs)

- KPM #3: Customer Service Percent of customers rating their overall satisfaction with the agency above average or excellent.
  - OVMEB has not met the 95% target. It is unclear how these values were determined in reporting years prior to 2021. However, the results presented in the supplemental document are for "excellent" and "good" responses only. By either measure, there has been improvement in each measure since 2021.
- KPM #4: Best Practices Percent of best practices met by the Board.
  - OVMEB has not reported any data for this KPM in 3 of the last 5 reporting years. For 2021, we were able to determine a 74% of best practices being met. For the current reporting period, we have received responses from all seven board members who reported 94% of best practices being met.

#### Key Performance Measures (KPMs)

- KPM #5: Percent of registered veterinary facilities inspected not less than once per biennium.
  - OVMEB has not met this target. This is largely due to the addition of pharmacy inspections. However, by law and rule, facility inspections are required every 3 years, rather than every 2 as this KPM measures. As of June 30, 2022, 40% of all veterinary facilities had been inspected. If a facility was not due for a full facility inspection during this reporting period, that facility got selected for a virtual pharmacy inspection for the 2022-23 fiscal year. All facilities that are due for a full facility inspection will be inspected in 2022-23 and the inspection numbers will be closer to 100% completion rate for our next reporting period. These facilities will also get the pharmacy inspection at the same time as the full inspection. Completion rate for pharmacy inspections is 98% for this reporting period because they can and have been done virtually.

#### COVID Response

- 2021 renewal fees waived for DVMs (active and inactive), CVTs, and CETs.
- Board allowed renewal deadline to be postponed from Dec. 31 to Jan. 31, 2021.
- Temporary rule on abiding by Executive Orders and guidance regarding emergency declarations was implemented in Aug. 2020 and will lapse Feb. 12, 2021.
- Telemedicine rule was implemented February 2020.
- Regular and repeated communications to licensees about COVID guidelines, vaccinations, and referrals to resources made.
