Re: Statistics of OT / OTA renewal fees and licensee count, per state.

During the February 9, 2023 hearing of the Occupational Therapy Licensing Board's budget, Rep. McLain requested the renewal fee and licensee count per state. Attached is the information requested. In reviewing the data here are some considerations:

- The fee data is not tracked by our national OT organizations. The national association, (AOTA) stated it was too difficult to track and that not all states have their fees published in regulation, and sometimes the names for fees are different, making it difficult to compare. The fees provided on the attached list are based on research by the board staff based on review of state regulations and websites.
- 2. In researching this information, we have found a variety of different fee structures among states. Some states may charge less for a renewal fee but charge a greater amount for reinstatement / late fees, temporary licenses, limited permits or application fees.
- 3. Additionally, some boards include charges for name changes, wall certificates, license replacements, inactive licenses, as well as a fee to complete the jurisprudence exam. The Oregon OT board does not charge for these items.
- 4. Senator Dembrow asked how the state boards are funded. This information is also not tracked by the AOTA. Board staff reviewed state websites as noted above; however, it was not clear by reviewing the websites and regulations which states receive funding by the state and which fees are paid solely by licensees. It is also possible that state OT board budgets may be combined with other health boards in setting the fees.
- 5. Three new educational programs are starting up in Oregon in the next two years. If the board finds that it has extra reserves due to an increase in licensure, the board would likely reduce its fees. The board has reduced its fees before, in 2008 and 2010.
- 6. The OTLB 23-25 budget/fee increase was presented to the state association (OTAO) leadership on February 3, 2023. They did not oppose the fee increase and reacted in support of the OTLB.
