## **SUMMARY**

Specifies that term "early childhood care and education" includes early childhood behavioral and mental health services for purposes of scholarships and grants awarded to ensure state has adequate supply of early childhood care and education professionals.

Requires person to accept state and federal aid grants, institutional aid grants and scholarships made available to person to be eligible to receive scholarship. Allows for award methodology that takes into consideration other financial assistance person has received.

Declares emergency, effective on passage.

- 5 **SECTION 1.** ORS 329.181 is amended to read:

  - (a) The reduction of the costs of the programs in the event amounts requested under the programs exceed amounts available for the programs.
  - (b) An award methodology for scholarships that takes into consideration state and federal aid grants, institutional aid grants and scholarships received by a person.

<u>SECTION 3.</u> This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect on its passage.
