#### **SUMMARY**

Requires Department of Education to approve training program in restraint and seclusion of student only if program is one of nationally recognized programs that has been designated by Department of Human Services as satisfying department's certification requirements for use of restraint and seclusion. Requires restraint and seclusion of student in public education program to be used only when imposed by certified personnel.

Provides that violation of restraint or seclusion law is abuse for purposes of Department of Human Services investigations of allegations of child abuse.

Allows Department of Human Services to find public education program is responsible for abuse related to use of restraint and seclusion by personnel of public education program in certain circumstances. Authorizes Superintendent of Public Instruction to find public education program is non-standard when specified violations involving restraint or seclusion occur.

Declares emergency, effective on passage.

#### 1 A BILL FOR AN ACT

- 2 Relating to qualifications for use of physical restraint in schools; creating
- 3 new provisions; amending ORS 339.291, 339.294, 339.297, 339.300 and

- 5 Be It Enacted by the People of the State of Oregon:
- 6 **SECTION 1.** ORS 339.300 is amended to read:
- 7 339.300. [The Department of Education shall approve training programs in
- 8 restraint and seclusion that:]
- 9 [(1) Teach evidence-based techniques that are shown to be effective in the
- 10 prevention and safe use of restraint or seclusion;]
- 11 [(2) Provide evidence-based skills training related to positive behavior sup-
- 12 port, conflict prevention, de-escalation and crisis response techniques; and]

- [(3) Are consistent with the philosophies, practices and techniques for restraint and seclusion that are established by rule or policy of the Department of Human Services.] The State Board of Education shall adopt by rule the training requirements for purposes of ORS 339.285 to 339.303. The rules must provide:
  - (1) That the Department of Education shall approve a training program that teaches the use of restraint and seclusion only if the program is one of the nationally recognized programs that has been designated by the Department of Human Services under ORS 418.529 (1)(b) as meeting the training and certification standards adopted under ORS 418.529. Only a program approved under this subsection may be used to satisfy the training requirements of ORS 339.285 to 339.303.
  - (2) The standards by which the Department of Education may approve training programs that supplement the training program described in subsection (1) of this section, including training programs related to positive behavior support, conflict prevention, de-escalation and crisis response techniques. A supplemental training program approved under this subsection may not be used to teach the use of restraint or seclusion or to satisfy the training requirements of ORS 339.285 to 339.303.
- SECTION 2. ORS 339.291 is amended to read:

- 339.291. (1) Restraint or seclusion may not be used for discipline, punishment, retaliation or convenience of personnel, contractors or volunteers of a public education program.
- 25 (2)(a) Restraint may be used on a student in a public education program 26 only under the following circumstances:
- 27 (A) The student's behavior imposes a reasonable risk of imminent and 28 substantial physical or bodily injury to the student or others; and
- 29 (B) Less restrictive interventions would not be effective.
- 30 (b) Seclusion may be used on a student in a public education program 31 only under the following circumstances:

- 1 (A) The student's behavior imposes a reasonable risk of imminent and serious bodily injury to the student or others; and 2
- (B) Less restrictive interventions would not be effective. 3
- (3) If restraint or seclusion is used on a student, the restraint or seclusion 4 must be: 5
- (a) Used only for as long as the student's behavior poses a reasonable risk 6 as described in subsection (2) of this section; 7
- (b) Imposed by personnel of the public education program who are[:]cur-8 rently certified regarding the use of restraint and seclusion by a cur-9 rently certified trainer authorized by a program approved under ORS 10 339.300 (1); and 11
- 12 [(A) Trained to use restraint or seclusion through programs described in ORS 339.300; or] 13
- [(B) Otherwise available in the case of an emergency circumstance when 14 personnel described in subparagraph (A) of this paragraph are not imme-15 diately available due to the unforeseeable nature of the emergency circum-16 stance; and] 17
- (c) Continuously monitored by personnel of the public education program 18 for the duration of the restraint or seclusion. 19
- (4) In addition to the requirements described in subsection (3) of this 20 section[,]: 21
- (a) If restraint or seclusion continues for more than 10 minutes, 22 every five minutes after the first 10 minutes of the restraint or seclusion, an administrator for the public education program must provide written authorization for the continuation of the restraint or seclusion, including providing documentation for the reason the restraint or seclusion must be continued.

- [(a)] (A) The student must be provided with adequate access to the 29 bathroom and water every 30 minutes; and 30

- 8 **SECTION 3.** ORS 339.294 is amended to read:

- (a) Verbal or electronic notification of the incident by the end of the

- 18 (A) A description of the restraint or seclusion, including:
- 19 (i) The date of the restraint or seclusion;
- 20 (ii) The times when the restraint or seclusion began and ended; and

- (3) If the personnel of the public education program who administered the restraint or seclusion [had not received training as provided by ORS 339.300] is not currently certified regarding the use of restraint and seclusion through a program approved under ORS 339.300 (1), the administrator of the public education program shall ensure that a parent or guardian of the student, [and] the district superintendent and the Department of Education receive written notification of:

  - (4) If the restraint or seclusion was administered in violation of ORS 339.285 to 339.303 or 339.308, the administrator of the public education program shall immediately notify the Department of Human Services as required by ORS 419B.010 and 419B.015.
- [(4)(a)] (5)(a) A debriefing meeting related to the use of restraint or seclusion must be held within two school days of the incident and must include all personnel of the public education program who were involved in the incident and any other appropriate personnel.
- 22 (b) Written notes must be taken of the debriefing meeting, and a copy of 23 the written notes must be provided to a parent or guardian of the student.
- [(5)] (6) If a student is involved in five incidents in a school year involving restraint or seclusion, a team consisting of personnel of the public education program and a parent or guardian of the student must be formed for the purposes of reviewing and revising the student's behavior plan and ensuring the provision of any necessary behavioral supports.
- [(6)] (7) If serious bodily injury or death of a student occurs in relation to the use of restraint or seclusion[,]:
  - (a) Oral notification of the incident must be provided immediately

- 3 **(b)** Written notification of the incident must be provided within 24 hours
- 4 of the incident to the parent of the student and the Department of Human
- 5 Services.
- 6 [(7)] (8) If serious bodily injury or death of personnel of the public edu-
- 7 cation program occurs in relation to the use of restraint or seclusion, written
- 8 notification of the incident must be provided within 24 hours of the incident
- 9 to:

- (a) The Superintendent of Public Instruction;
- 11 **(b)** The district superintendent [and,]; and
- (c) If applicable, to the union representative for the affected party.
- [(8)] (9) Each public education program must maintain a record of each
- 14 incident in which injuries or death occurs in relation to the use of restraint
- 15 or seclusion.
- 16 (10)(a) For at least six months following an incident involving re-
- 17 straint or seclusion, a public education program must preserve all re-
- 18 cords related to the incident, including video and audio recordings.
- 19 Records must be preserved in the original format and without any al-
- 20 terations.
- 21 (b) Unless otherwise directed by the Department of Human Services
- 22 or law enforcement, a public education program must disclose records
- 23 described in paragraph (a) of this subsection, and any other records
- 24 made following an incident, immediately upon request by the Depart-
- 25 ment of Human Services, a person authorized by the Department of
- 26 Human Services to conduct a child abuse investigation or the
- 27 student's parent or guardian.
- 28 **SECTION 4.** ORS 339.297 is amended to read:
- 29 339.297. (1) Each entity that has jurisdiction over a public education
- 30 program must prepare and submit to the Department of Education an annual
- 31 report detailing the use of restraint and seclusion for the preceding school

- 1 year, including, at a minimum:
- 2 (a) The total number of incidents involving restraint.
- 3 (b) The total number of incidents involving seclusion.
- 4 (c) The total number of seclusions in a locked room.
- 5 (d) The total number of rooms available for use by the public education 6 program for seclusion of a student and a description of the dimensions and
- 7 design of the rooms.
- 8 (e) The total number of students placed in restraint.
- 9 (f) The total number of students placed in seclusion.
- 10 (g) The total number of incidents that resulted in injuries or death to 11 students or personnel as a result of the use of restraint or seclusion.
- (h) The number of students who were placed in restraint or seclusion more than 10 times in the course of a school year and an explanation of what steps have been taken by the public education program to decrease the use of restraint and seclusion for each student.
- (i) The number of incidents in which the personnel of the public education program administering restraint or seclusion were not [trained as provided by ORS 339.300] currently certified regarding the use of restraint and seclusion through a program approved under ORS 339.300 (1).
- (j) The demographic characteristics of all students upon whom restraint or seclusion was imposed, including race, ethnicity, gender, disability status, migrant status, English proficiency and status as economically disadvantaged, unless the demographic information would reveal personally identifiable information about an individual student.
- 25 (2)(a) Each entity that has jurisdiction over a public education program 26 shall make its annual report about restraint and seclusion available to:
- 27 (A) The public at the entity's main office and the website of the entity;
- 28 (B) The board or governing body overseeing the entity;
- (C) If the entity is an education service district, the component school districts of the education service district; and
- 31 (D) If the entity is a public charter school, the sponsor of the public

- 2 (b) Parents and guardians of students in a public education program shall 3 be advised at least once each school year about how to access the report.
- (3) A public education provider that does not comply with the requirement to submit a report to the Department of Education under subsection (1) of this section or to make the report available as described in subsection (2) of this section is considered nonstandard under ORS 327.103.
- 8 <u>SECTION 5.</u> (1) The amendments to ORS 339.291, 339.294, 339.297 and 9 339.300 by sections 1 to 4 of this 2023 Act become operative on July 1, 2024.

- 2 (q) A court appointed special advocate, as defined in ORS 419A.004.
- 3 (r) A child care provider registered or certified under ORS 329A.250 to 329A.450.
- 5 (s) An elected official of a branch of government of this state or a state
- 6 agency, board, commission or department of a branch of government of this
- 7 state or of a city, county or other political subdivision in this state.
- 8 (t) Physical, speech or occupational therapist.
- 9 (u) Audiologist.
- 10 (v) Speech-language pathologist.
- 11 (w) Employee of the Teacher Standards and Practices Commission directly
- 12 involved in investigations or discipline by the commission.
- 13 (x) Pharmacist.
- 14 (y) An operator of a preschool recorded program under ORS 329A.255.
- 15 (z) An operator of a school-age recorded program under ORS 329A.255.
- 16 (aa) Employee of a private agency or organization facilitating the pro-
- 17 vision of respite services, as defined in ORS 418.205, for parents pursuant to
- 18 a properly executed power of attorney under ORS 109.056.
- 19 (bb) An employee of a public or private organization providing child-
- 20 related services or activities:
- 21 (A) Including but not limited to an employee of a:
- 22 (i) Youth group or center;
- 23 (ii) Scout group or camp;
- 24 (iii) Summer or day camp;
- 25 (iv) Survival camp; or
- (v) Group, center or camp that is operated under the guidance, super-
- 27 vision or auspices of a religious, public or private educational system or a
- 28 community service organization; and
- 29 (B) Excluding an employee of a qualified victim services program as de-
- 30 fined in ORS 147.600 that provides confidential, direct services to victims of
- 31 domestic violence, sexual assault, stalking or human trafficking.

- 1 (cc) A coach, assistant coach or trainer of an amateur, semiprofessional
- 2 or professional athlete, if compensated and if the athlete is a child.
- 3 (dd) Personal support worker, as defined in ORS 410.600.
- 4 (ee) Home care worker, as defined in ORS 410.600.
- 5 (ff) Animal control officer, as defined in ORS 609.500.
- (gg) Member of a school district board, an education service district board
  or a public charter school governing body.
- 8 (hh) An individual who is paid by a public body, in accordance with ORS
- 9 430.215, to provide a service identified in an individualized written service
- 10 plan of a child with a developmental disability.
- 11 (ii) Referral agent, as defined in ORS 418.351.
- 12 <u>SECTION 8.</u> Section 9 of this 2023 Act is added to and made a part 13 of ORS 339.285 to 339.303.
- 14 SECTION 9. (1) As used in this section:

- 15 (a) "Behavior intervention plan" has the meaning given that term 16 in ORS 343.154.
- 17 (b) "504 Plan" means an education plan developed for a student in 18 accordance with section 504 of the Rehabilitation Act of 1973, 29 U.S.C. 19 794.
  - (c) "Individualized education program" has the meaning given that term in ORS 343.035.
- 22 (2) When the Department of Human Services conducts an investi-23 gation under ORS 419B.019 of a report of suspected abuse that involves 24 the use of restraint or seclusion and the department finds that the 25 report of abuse is founded, the department may determine that the 26 public education program is responsible for the abuse instead of, or in 27 addition to, the personnel of the public education program who im-28 posed the restraint or seclusion if:
- 29 (a) The public education program failed to ensure that a sufficient 30 number of personnel who are certified regarding the use of restraint 31 and seclusion through a program approved under ORS 339.300 (1) were

- available to comply with the individualized education programs, 504 Plans and behavior intervention plans of the students who were present in the setting where the abuse occurred at the time the abuse occurred and the personnel who imposed the restraint or seclusion reasonably believed failure to do so would lead to serious bodily injury of the student or others; or
  - (b) The personnel who imposed the restraint or seclusion in violation of ORS 339.285 to 339.303 or 339.308 did so because the personnel were ordered to do so by a superior and reasonably believed that failure to comply with the order would result in termination or discipline.
  - (3) If the Department of Education is notified by the Department of Human Services that, within a 12-month period, the Department of Human Services made the finding that three or more reports involving allegations of abuse related to restraint or seclusion and involving the same public education program were founded, the Superintendent of Public Instruction shall find the public education program nonstandard under ORS 327.103 or 334.217.
- SECTION 10. (1) Section 9 of this 2023 Act and the amendments to ORS 419B.005 by sections 6 and 7 of this 2023 Act become operative on July 1, 2024.
  - (2) Section 9 of this 2023 Act and the amendments to ORS 419B.005 by sections 6 and 7 of this 2023 Act apply to incidents involving the use of restraint or seclusion occurring on or after July 1, 2024.
    - SECTION 11. This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect on its passage.
