REPRESENTATION OF THE DIVISION OF CHILD SUPPORT

- Establish, modify and ensure compliance with child support orders; establish paternity/ parentage; pursue contempt actions when the paying parent does not pay support
- Training and education:
 - Child Support Bench Book
 - Training to DCS staff, private attorneys, DDAs and OJD

RECOVERIES

- Payments to Oregon families increases after contempt actions are filed
- Holistic, problem-solving approach emphasis on consistent payments and employment
- Flexibility in responding to changing conditions, including pandemic and wildfires



Civil Recovery – Wildfire Investigations and Cost Recovery



The Oregon Dept. of Forestry (ODF) investigates wildfires that start on state-protected land. We assist ODF with many of its larger investigations and help state agencies recover their firerelated losses.



The US Forest Service and Bureau of Land Management investigate fires that start on federal land. If those fires spread to state-protected lands, we represent ODF and other state agencies in cost recovery actions if a responsible party is identified.







Child Advocacy

Program attorneys represent the Oregon Department of Human Services Child Welfare Division (ODHS) in matters of child safety and supporting families:

- Provide litigation support and legal advice in all Juvenile Dependency and Termination of Parental Rights cases
- Appear at administrative hearings regarding licensing and foster care certification cases and prepare agency final orders
- Responsible for general legal advice specific to issues impacting child welfare and child safety




Court Hearings and Trials

Attorneys prepare for and appear on behalf of ODHS caseworkers at a significant number of court hearings statewide, including many complex multi-day trials. Preparation can include:

- witness and exhibit preparation
- subpoenas
- legal service
- filing pleadings
- drafting judgments
- settlement discussions
- reviewing voluminous discovery




Legal Advice to Child Welfare Programs



Pre-Removal Emergency Legal Advice

Attorneys provide emergency consultation to Child Welfare caseworkers in all counties to determine whether ODHS has legal sufficiency to remove a child and to prevent unnecessary trauma of removal



Impact of Emergency Legal Advice

Number of children entering foster care during FFY 2021 decreased 13.7% from the FFY 2020 level, aligning with and supporting ODHS Child Welfare's work in their Vision for Transformation

Number of juvenile dependency petitions filed in court statewide in 2021 decreased 20% from the number filed in 2020

Number of emergency shelter/removal court hearings held in 2021 decreased 10.7% from the number held in 2020

Shift to New Legal Division - POP #201

The Department of Justice seeks to establish its Child Advocacy Program as a new legal division distinct from the Civil Enforcement Division.


Department of Justice: Trial Division



Program Summary

- The Trial Division defends the State when it is sued for money damages or someone petitions the court to order the State to take or refrain from action.
- If the State does not appear in the case, or fails to respond to a motion, a judgment can be entered in favor of the opposing party.

Factors Affecting Workload Caseload Entirely Dependent Upon Others

- Lawsuits for money damages or to compel state action
- SB 1584 Wrongful Conviction Compensation
 - 23 Notices of Intent to File
 - Impact of Ramos/Watkins
- Oregon Department of Transportation highway improvement projects (250 new cases so far this biennium)
- Convicted criminals (usually Measure 11) suing to overturn their convictions
- Licensees/others attempt to overturn agency orders
- Public records requests

Trial Division – DCC Resources

- 39 of 135 Positions devoted to Defense of Criminal Convictions.
- \$16.47 million budget for DCC work.
- Nearly 3,500 cases for the 23-25 biennium.
 - Post Conviction Trial
 - Federal Habeas Trial
 - PSRB Psychiatric Security Review Board
- Approximately 65,000 hours of work for the 23-25 biennium.

POP 400 – Reduce Need for Outsourced Legal Counsel

- The volume of civil cases has increased to the point where the division has had to outsource many cases to private law firms.
- Private law firms charge, at times, twice the rate of DOJ attorneys and paralegals.
- Based on 18 months of private firm invoices, the state could have saved \$1,786,556 had DOJ attorneys and paralegals performed the work.





Recent changes in the law

Nonunanimous juries

- Apodaca v. Oregon (1972): Sixth Amendment allows nonunanimous juries in state court
- **Ramos v. Louisiana** (U.S. Sup. Ct. 2020): Sixth Amendment requires unanimous jury

Implementation

 470+ cases on direct appeal reversed and sent back for new trials

Recent changes in the law

Nonunanimous juries (continued)

• Watkins v. Ackley (Or. Sup. Ct. 2022): State statute requires new trials in cases that were final before Ramos was decided

Implementation

- Conceding relief for post-1989 convictions where there is a clear record of only nonunanimous verdict(s)
- Continuing to litigate disputed claims
 - Cases with unanimous and nonunanimous verdicts
 - Cases with no jury poll; juror contact
 - Cases with no jury trial (e.g., guilty plea)
 - Convictions that became final before 1989

Recent changes in the law

Capital cases

- State v. Bartol (Or. Sup. Ct. 2021): Death penalty unconstitutional if not eligible under current law
 - Effectively invalidate death penalty in almost all pending capital cases
- Governor Brown commuted all pending death sentences to life without the possibility of parole
- Cases continue as non-capital (but still enormously complex) litigation if person is seeking a new trial or lower sentence



 - State is a party in every criminal and post-conviction case and most civil cases
- Oregon Supreme Court
 - State is a party in most cases

Appellate Division



Types of Cases

- Defense of criminal convictions
 - Direct appeals, post-conviction appeals, and federal habeas corpus appeals
- Civil
 - Tax, contracts, torts, civil commitment, juvenile dependency, challenges to statutes
- Administrative
 - Professional and other licenses, regulatory decisions that impose fines or other penalties, benefits decisions, rule challenges

We are the respondent in almost all of these cases: The other side has appealed and we must respond.

Recent Examples

• County of Linn v. State (Oregon Court of Appeals)

Overturned \$1.1 billion verdict against the state over management of state forests.

• Whitehead v. Fagan (Oregon Supreme Court)

Signatures from voters with inactive registration do not count for initiative petitions.

• *Murdoch v. DMV* (Oregon Supreme Court)

DMV properly suspended license of person who refused a breath test.

Previous Budget Action

- The 2021 Legislature approved Package #441 Nonunanimous Jury Appeals to add 1 position (0.88 FTE) to allow the Appellate Division to handle the additional caseload associated with expected appeals related to nonunanimous juries.
 - We have largely addressed cases on direct appeal; the recent decision in *Watkins v. Ackley* should help move forward the post-conviction appeals.
- The 2022 Legislature added 1 position (0.21 FTE) to handle appeals in the new proceedings for compensation for wrongful convictions. Those cases have not yet made it up on appeal.

POP #450 – Appellate Civil Paralegal

 To provide for the most efficient way to process judicial review and rule challenges in the Oregon Court of Appeals. Position will also draft motions, affidavits and responses in juvenile dependency, civil, and administrative appeals. This position will perform these duties and administrative records work at a lower cost to client state agencies.
