Subject: HB 5045 - 2021-23 Budget Rebalance Work Session Recommendations

HB 5045 relates to state financial administration and is an omnibus budget bill that rebalances state agency budgets, makes statewide adjustments for debt service, and includes other select budgetary changes for the 2021-23 biennium. No budget notes are recommended. The -3 amendment replaces the measure to implement the specific budget adjustments.

The following table summarizes the overall changes to the 2021-23 legislatively approved budget:

Major adjustments in the measure include:

- Emergency Board
 - \$77.1 million General Fund <u>decrease</u> for the disappropriation of the remaining balance in the Emergency Fund
- Oregon Health Authority

- \$315.4 million General Fund <u>decrease</u> and \$1.5 billion total funds <u>increase</u> to rebalance the agency's budget
- o \$25 million General Fund *increase* to support hospital bed capacity
- Department of Human Services
 - \$299.8 million General Fund <u>decrease</u> and \$134.4 million total funds <u>increase</u> to rebalance the agency's budget
 - \$9.4 million General Fund <u>increase</u> for the Office of Resiliency and Emergency Management; \$7.5 million General Fund <u>increase</u> for the Oregon Food Bank; and \$3.3 million General Fund <u>increase</u> for distressed providers of community-based care
- Department of Emergency Management
 - Net-zero transfers for the final budgetary transactions to establish the new department; and a net \$2.3 million General Fund <u>increase</u> for construction of the Emergency Communications Center in the department's headquarters
- Department of Justice
 - \$3.2 million General Fund *decrease* for a caseload forecast adjustment
- Public Defense Services Commission
 - \$1.1 million General Fund *increase* for cases associated with the Watkins v. Ackley court decision (December 30, 2022) on nonunanimous jury convictions
- Department of Transportation
 - \$270 million Other Funds <u>increase</u> for emergency response maintenance (\$70 million) and existing modernization projects (\$200 million)
- Housing and Community Services Department
 - Transfer of \$74.1 million in existing General Fund appropriations to Other Funds accounts to continue supporting existing housing initiatives into the 2023-25 biennium
- Department of Administrative Services
 - \$15.7 million Other Funds <u>increase</u> for Department of Justice expenses, publishing services, Federal Emergency Management Agency reimbursement, and Mill Creek transaction costs
- Department of State Lands
 - \$3.3 million Other Funds <u>increase</u> for the removal and cleanup of abandoned and derelict vessels on submerged lands owned by the state
