The Mission of the Office of the Public Records Advocate

- Mediate disputes between public records requesters and records custodians
- Provide guidance and advice on matters pertaining to public records request processing and the disclosure and applicability of exemptions from disclosure of public records
- Train public employees on the requirements and best practices of Oregon's public records
- Serve as a voting member, executive director, and employee of the Public Records Advisory Council





The Goals of the Office of the Public Records Advocate

- Improve communication between public records requesters and custodians
- Provide requesters and custodians alike with a common understanding of the requirements and best practices under the law
- Look for creative solutions
- De-escalate tense or difficult requests to facilitate efficient and fare records disclosure



The History of the Office of the Public Records Advocate

2021:

SB 500 declares the Office of the Public Records Advocate as an independent office within the executive department

Establishes the Public Records Advocate Fund in the State Treasury

2023:

HB 5032 - Public Records Advocate budget bill

SB 510 - Directs
Public Records
Advocate to assess
costs among public
bodies of state
government

2019:

Departure of first Public Records
Advocate due to perceived political interference

Key Performance Measures to be Established for the Office of the Public Records Advocate

- (1) Timely Respond to Requests for Assistance
- (2) Multi-point Requests for Assistance Tracking
- (3) Increased Outreach to and Training of Affinity Groups
- (4) Creation of Additional Online Resources

Cost savings realized

- (1) Staff are Working Remotely
- (2) Maintain Paperless Office
- (3) Continued Availability of In Person and Online Trainings



District Attorneys' Public Records Orders Database







15% reduction options:

- <u>5% Reduction 1</u>: \$36,322 Eliminates in-state and out-of-state travel expenses by limiting all trainings to remote attendance and cutting all personnel training to remote attendance. Also eliminates costs and fees allocated with employee development and leadership training, and publicity and publications, and other S&S.
- 10% Reduction 2: \$72,644 Reduce Deputy PRA from 1.0FTE to 0.75 FTE.
- <u>15% Reduction 3</u>: \$108,966: Reduction 1 and 2 plus additional cuts to Services and Supplies
