### Measure Description:

Requires the State Fire Marshal to establish a grant and incentive program that supports communities, counties, and the public in reducing wildfire risk and prioritizing need-based applicants. Requires the State Fire Marshal to establish a neighborhood protection cooperative program. Appropriates money to the Department of the State Fire Marshal.

# Analysis:

The measure provides for a one-time \$10 million General Fund appropriation to the Department of the State Fire Marshal (DSFM) for the biennium beginning July 1, 2023 for deposit into the Community Risk Reduction Fund. The measure also directs DSFM to establish a grant and incentive program, using the General Fund appropriation, to support communities, counties, and the public in reducing wildfire risk and prioritizing need-based applicants; and to establish a neighborhood protection cooperative program to coordinate, streamline, and improve Oregon programs that assist with reducing wildfire risks around buildings and in neighborhoods, through on-site consultations and cooperative practices.

In addition, the measure directs DSFM to modify the agency's website to include a central, user-friendly site that clearly describes all programs, grant opportunities, and citizen input processes related to community risk

reductions. DSFM, in consultation with appropriate state agencies, counties, community organizations, fire service providers, and other partners, is to develop a 20-year strategic plan that prioritizes fire resiliency and building fire-adapted communities.

Lastly, DSFM is to establish an interagency data collection system to enable cooperation on wildfire risk reduction investments related to services and activities under the community risk reduction program. The measure modifies the biannual report the agency is to provide to a committee or interim committee of the Legislative Assembly related to wildfires. The measure declares an emergency and is effective upon passage.

DSFM anticipates the fiscal impact of the measure to be \$16.3 million General Fund and 16 permanent, full time positions (12.42 FTE) for the 2023-25 biennium. The roll-up cost for positions as well as services and supplies needed to deliver the provisions of the bill is estimated to be \$5.6 million for the 2025-27 biennium. The General Fund appropriation to the Community Risk Reduction Fund is considered one-time in nature and therefore is not included in the fiscal impact for the 2025-27 biennium. Positions include:

There is a minimal fiscal impact for the Oregon Department of Forestry, Department of Consumer and Business Services, Burns Paiute Tribe, Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians, Confederated Tribes of Siletz, Confederated Tribes of Warm Springs, Confederated Tribes of Grande Ronde, Confederated Tribes of Umatilla Indian Reservation, Coquille Indian Tribe, Cow Creek Band of Umpqua Indians, Klamath Tribes, Special Districts Association of Oregon, and counties.

There is no fiscal impact for the Department of Land Conservation and Development, Higher Education Coordinating Commission, Oregon Department of Fish and Wildlife, and cities.

The Legislative Fiscal Office notes that the measure does not include Other Funds expenditure limitation to allow DSFM to expend the \$10 million General Fund from the Community Risk Reduction Fund.

This measure warrants a subsequent referral to the Joint Committee on Ways and Means for consideration of its budgetary impact on the State's General Fund.
