



Economic Impact of Oregon Agriculture \$ 5,099,288,000

15.4% of Oregon's economy

Oregon agriculture contributes \$33.3B to the state's economic footprint.

Provides 20.3% of Oregon jobs

86,240 employees directly engaged in Oregon agriculture. 30% of farms hire labor outside of owner.

\$344M local or regional, CSA, farm stands, farmers market sales








Meaning Behind Our Logo



Organizational Structure





Food Safety and Animal Health (FS/AH)



✓ Food Safety Program

To prevent foodborne illness we inspect, educate, and enforce Oregon's food safety and sanitation laws. *State Meat Inspection

✓ Animal Health

To promote and protect Oregon's livestock we control diseases, prevent theft, support predator control, and ensure animal feed is safe.

✓ Lab Services

Internationally and nationally accredited labs to support agriculture and other local, state, and federal agencies.



FS/AH 2021-23 Highlights



✓ Reusable Container Rule

Updated rules to responded to changes in consumer behavior and demand to provide food retail facilities flexibility to allow the use of reusable containers.

✓ Livestock ID (Brands)

Approx. 1.1 million cattle and horses inspected annually for ownership verification. Restructured so regional managers can have direct interaction with regional inspectors.

✓ Lab Services

Receives over 5,000 samples and timely processes over 12,000 tests annually. Maintained ISO accreditation.

Natural Resource Program Area (NRPA)



✓ Water Quality

Compliance to prevent pollution and soil erosion from agricultural activities and partnerships to help working lands achieve water quality goals

✓ Agriculture & Consumer Products

Regulate and educate on the sale and use of pesticides, fertilizers, and soil amendments to support the safe and effective agriculture production.

✓ Natural Resource Protection

Incorporate Oregon's land use laws, CAFO laws, and Right to Farm laws to sustain natural resources for future generations.



NRPA 2021-23 Highlights



✓ Update ODA-DEQ Water Quality MOA

Worked with agency staff, Board of Ag, EQC, Tribes, and public to better achieve water quality goals related to ag nonpoint source pollution.

Pesticide Enforcement Backlog Elimination

Made significant progress on COVID-related backlog of 250+ cases and adjusted case review process to reduce future backlogs.

✓ Pesticide Certification Improvements

EPA approval of Oregon pesticide applicator certification plan with updates to federal regulations; will be fully implemented by 2030.

Market Access and Certification (MAC)



✓ Market Access

Connect buyers and sellers of Oregon products in domestic and international markets. Coordinate local opportunities with schools to international trade missions.

Certification & Inspection

Facilitate successful market activity by ensuring certification standards, grades, size, and quality measures are met.

✓ Weights and Measures/Motor Fuels

Inspect and calibrate scales and meters in Oregon to protect the consumer and promote fair market practices. ODA also protects fuel consumers from faulty or false sales of fuels.



MAC 2021-23 Highlights



✓ Quality Assurance

16,400,000,000(B) pounds of ag commodities inspected, and 265,000,000(M) pounds of seed tested by ODA for commerce. Over 340 food safety and organic audits performed.

✓ Grant Opportunities

Administered six (6) distinct grants to invest over \$10,892,000 in the ag economy, including \$2,000,000 for state meat processing capacity.

✓ Consumer Confidence

Over \$107 billion of goods and products are sold over ODA certified scales or meters in Oregon. 63,000+ devices are certified annually to ensure consumer protection, fair competition, and encourage economic prosperity.

Plant Protection and Conservation Program (PPCP)



✓ Nursery, Christmas Tree & Hemp

Prevents the introduction and spread of injurious plant pests and weeds through inspection & certification of Oregon nursery stock. Enforcement of state and federal laws protect and support legal hemp and nursery growing operations.

✓ Insect Pest Prevention & Noxious Weeds

Protects Oregon's agricultural and natural resources from damaging insect pests and noxious weeds through statewide survey and eradication efforts.

✓ Plant Conservation

Promotes and conserves native plant populations through research, permitting and collaborative projects.



PPCP 2021-23 Highlights



✓ Enforcement

Increased testing of licensed hemp growers by 50% and saw a significant decrease in failed Presumptive Testing. Removal of imported & infested geraniums prevented the introduction of a deleterious pathogen of potato and other high value crops.

✓ Funding Opportunities

Granted \$450,000 in infrastructure funding to support county-level noxious weed control projects. IPPM maintained \$1million in federal funding to execute 13 statewide projects to safeguard Oregon against destructive plant pests.


