#### WHAT THE MEASURE DOES:

Provides that the Oregon Fish and Wildlife Commission must be appointed by the Governor and must consist of one member from each of Oregon's five regional river management areas, one member from east of the Cascade Mountains and one member from west of the Cascade Mountains.

## **BACKGROUND:**

The Oregon Fish and Wildlife commission was formed in 1975 with the purpose to formulate general state programs and policies concerning management of fish and wildlife resources and to establish seasons, methods and bag limits for commercial and recreational take. Currently one member of the commission is appointed from each congressional district in addition to one member from east of the Cascade Mountains and one member from west of the Cascade Mountains.

House Bill 3086 would change the make up of the Oregon Fish and Wildlife commission to consist of one member from each of Oregon's five regional river management areas and one member from both east and west of the Cascade Mountains.
